## The President of the Association, Becky Newmon

- Spring show
  - o 51 horses
  - Lower attendance reasons:
    - Existing conflicts
    - Footing? did not hear any complaints
    - Crime security was very tight
  - o Lost about \$6000
  - EXPO Bill was about \$8,400 (rather than HIPICO, which for the spring show was \$25,000); \$1,500 judge, \$1,400 secretary, \$7,700 arena crew; \$1,000 parking crew
    - Probably could eliminate parking person
- Fall show
  - o Rated vs. unrated
    - Need a sponsor extra \$10k needed for prize money if we do rated show
  - o Members' preference is for a Category I Show (which is unfortunately more

expensive) rather than a Category II

- Will need to raise stall prices
  - Need to be clear about why stall prices are going to be increasing \$75
- Recruitment for more entries
  - Social media posts re: preparing for Vegas
- o Molly & Becky will have conference meeting with Chris to finalize plans
- P.O. Box
  - o \$250 is expensive
  - o Rather keep it so it is not tied to a member of the board
- Trailer damage
  - o Trailer is no longer weatherproof
  - Melloy Mobile Moving
  - o Taylor/Robles, Rael & Anaya will write up a demand letter
    - Firm will execute a contract and NMHJA will be retained

  - Buffet is \$41 per person, that does not include any other overhead cost (for Mexican)
    - Maybe we move to \$44 Italian buffet
  - Keep date and venue
